(J-Tree is Calling)

One of the great things about holidays is traditions. And spending Thanksgiving at Joshua Tree is a hallowed AMC Tradition for good reason. The climbing at Joshua Tree is one word—AWESOME! Hundreds of routes, and days of climbing. There are easy top rope 5.7s to hangnail 5.12s. Lots of leads to test your skills, or seconding on routes that stretch your abilities. Even the infamous "bumper belays" and being surrounding by climbing walls all around you.

Thursday November 28 will be the traditional AMC Thanksgiving dinner—it is potluck, so bring your best recipe. Some folks may go out early, you can drive straight from work in 5 hours. If you go before Wednesday, make your own camping arrangements. AMC has the following sites reserved from noon Wednesday, 11/27 through noon Sunday 12/01:

Indian Cove group site #1 - 60 campers and only 20 cars

Indian Cove group site #2 -45 campers and only 8 cars

PLEASE NOTE: The maximum car limit will be strictly enforced this year. The park has adopted a new system where each car in a group site must have a parking permit in order to park there. For example, once the 8 permits have been given away for group site 2,other vehicles will have to park near the ranger station and walk to the site or get someone to give them a ride. CAR POOLING IS THE WAY TO GO.

We will post a list along with the number of parking permits for each site on Wednesday morning. When you arrive, if there are permits left, you can take one, but please sign your name on the list so we'll know who has all the permits. All campsites are primi-

tive, no water or electricity. If possible bring wood for evening campfires. The town of Joshua Tree, and 29 Palms are about 20 minutes away if you need a meal, motel, or shower. Space is very limited.

To get there, go towards Los Angeles on I-10 passing through Blythe and Desert Center. Watch for the Joshua Tree Cottonwood entrance. Drive about 1-hour north through the park - past White Tank and Belle campgrounds and the main park entrance. Go right at the 'T' intersection to 29 Palms. Then go west on Hwy 62 into 29 Palms. The turnoff to Indian Cove from Hwy 62 is west of 29 Palms.

There are usually about 40 to 60 AMCers in attendance, some folks go all week, some go for a day or two.

Weather is variable. Days are usually warm and sunny, nights will be chilly, and it is usually windy. Nothing is certain, so be prepared to get scorched, rained on, or whatever. There are numerous guidebooks available in the local shops, it is a good idea to own one for the correct portion of the park.

THANKSGIVING DINNER AT JTREE.

Thanksgiving Dinner at Jtree is usually a gustatory delight of epicurean heights. You can contribute your favorite recipe and bring other items needed. Clay Vollmer (vollmer@rice.edu) is the food coordinator for the potluck. Sign-up with Clay to bring side dishes, salads, breads, desserts, and meats. Dishes should be prepared and ready to serve. Stoves are usually available to keep food warm. Non-food items are also needed: Stoves and fuel, folding tables, lanterns, large pots, serving spoons, tablecloths, firewood, water to wash up. Bring your own utensils, beverages, dishes, and a chair.

Let's all work together and maybe we won't even need these documents, but in case something does occur, please read them so that you can fully avail yourself of the benefits they provide.

AMC Standing Rule 10-14-02-02

Member Conduct Procedure

- I. Bylaws. The Member Conduct Procedure set forth below is intended to be an addition to the "Standing Rules" of the Arizona Mountaineering Club ("AMC"). The Board of Directors of the AMC ("Board") is authorized to adopt Standing Rules pursuant to Paragraph 3, Section g, Subsection v and Paragraph 8 of the Bylaws of the AMC dated April 1999.
- II. Grounds for Discipline. A member of the AMC who engages in improper conduct, including, but not limited to, conduct that is in violation of AMC rules or documents; conduct that uses the members' names and information inappropriately; or conduct that has a reasonable possibility of compromising the welfare, interest, well being, character, safety, decorum or good reputation of

AMC or its members, may be subject to the disciplinary measures authorized by this Member Conduct Procedure. If disciplinary measures are to be imposed, they will be imposed in accordance with the procedure outlined below. AMC members also are responsible for the conduct of their family members, guests, and invitees.

- III. Disciplinary Measures. The Board may take the following disciplinary measures to enforce this Member Conduct Procedure:
 - A. Suspension of AMC membership or
 - B. Termination of AMC membership.

Terms and conditions of such disciplinary actions, e.g., length, reinstatement, and the like, may be specified by the Board.

- IV. Filing of Member Conduct Reports.
- A. Any member who has been subject to or observed inappropriate member conduct may submit a member conduct report ("Report").
- B. A member may file a Report by requesting assistance from any of the Board Members. If the Board Member feels that the Report is Non-Frivolous, the Board Member can assist the member with the completion of Reports. Completed Reports shall be submitted to the President of the AMC ("President"). If a Report is considered Frivolous or Inappropriate, the Board Member shall notify the President of such an opinion.
- C. Reports shall include the following items in writing: name of the reported member; date and time of the incident; nature of the incident and relevant facts; names of the persons witnessing the incident; name of the reporting member; and name of the Board member who assisted in preparing the Report.
- D. The Reports shall be signed and dated by the reporting member and by the Board member who assisted in the Report's preparation.
- V. Review of Member Conduct Reports.
- A. Within a reasonable period of time after receiving a Report but not to exceed two consecutive Board meetings, the President shall (Continued on page 9)

Early this year, David decided that he'd like to climb Devil's Tower for our summer vacation. We chose September because it would be cooler and there would be fewer people around. Heather Ryan and Al Falfa (Weikel) decided to go with us, so the plan for a joint venture to Devil's Tower for vacation started taking shape.

The drive to Devil's Tower was 1,300 miles one way. We decided to break up the drive a little with a stop in Colorado on the way, mooching a couple of nights and a CO climbing day off AMC members Tim and Penny Medlock.

We arrived in Colorado Springs late on Saturday night and were surprised to see Sue Goins at Tim and Penny's too. Sue moved to Buena Vista, CO about a year ago. We had an AMC reunion of sorts, complete with beer, pizza, and tall tales of climbing adventures. The next day, we climbed at a limestone crag called Shelf Road. It was some pumpy, sharp rock. It felt good to be out on the rock after so much time in the truck.

On Monday, we left CO and drove to Devil's Tower, WY. It's interesting the way they arranged it, rolling hills for miles and no sign of the tower until you're a couple of miles away. Then the tower suddenly appears -- and it looks pretty intimidating! We set up camp and geared up for the climb. We planned to do the Durrance Route the next morning. It's rated 5.6, but it's reportedly a tough 5.6. Listed in the book, Fifty Classic Climbs, it's been on Dave's tick list for a couple of years.

The next morning, we drove into the park and signed the climbers' register, which asked for the route, number in the party, and our next of kin. That always makes you feel good! The approach was damp and slippery and at one point, got pretty vertical. We sent Dave on ahead to set an anchor and drop us a life line. We dropped our packs and put harnesses on, clipping into the sling Dave dropped us, so that if we fell, we wouldn't end up back at the truck. It was crazy, and we weren't even climbing yet!

Dave led the whole route, with me seconding, and Al and Heather coming up after me. Dave ran the first two pitches together into one long one, followed by two short pitches, and finally a long pitch to the top. For the most part, I thought the climb was a strenuous grunt, but it was definitely cool to be climbing on Devil's Tower. It was a neat route because of the his-

torical significance, but not because it was fun climbing.

We had a guide with one client follow us up the route. This guy was talkative and friendly, but a bit on the rude side. On the last pitch, he took off after Dave was out of sight and followed him up the route, not placing any gear. He towed his lead rope, and a rope to haul up a haul bag. When it was my turn to climb, I had to keep navigating around his ropes. When Heather was bringing up the rear, he started belaying his client, who raced past Heather on the route. We had a few words with the guide and he had his client stop and wait for Heather to finish the pitch.

Up on top, we signed the register and took some summit photos. I read some of the other entries in the register. My favorite was the shaky handwriting from a man who wrote that he was 72 years old and not climbing quite as strong as he used to. I hope to be climbing at 72!

We rappelled right along side the Durrance Route back to the base of the tower. At one ledge, our friend the guide was rapping down behind us and freed his rope ends from the crack so they could land on our heads. I mentioned that it's a good idea to yell "ROPE" before you drop a rope on someone's head. Oh well. Someone behind him knocked an orange sized rock off and it bounced off Al's helmet. Time to get the heck out of there as fast as we could!

After the 3rd rappel, we grabbed our packs from near the base of the climb and took one more rap to the bottom. We were all glad we didn't have to walk back down that scary stuff we walked UP to get to the base of the climb. We were fortunate, there were no stuck ropes, no getting lost, no major mishaps all day long. As we were packing our stuff we realized we had left a rope bag up on the ledge. Our friend, the guide brought it down to us, so we couldn't be permanently mad at him.

As we came off the climbers trail onto the tourist trail, a couple who looked like they could be from a farm in Iowa stopped us so they could take a picture. "Look, there's some climbers! Stop there, so we can take your

AMC Standing Rule 10-14-02-01 - Leader's Rights to Deny or Limit Participation

The Leader of an AMC activity or function shall have the right to limit or deny participation in the activity to any prospective participant under his or her responsibility. The Leader shall make the determination whether or not a participant's engagement in activity is incowith the overall function of the activity or with the well being and health of the other participants. The Leader can either exercise this discretion in the prior selection of the participants or in observing the behavior of a participant during the activitynsist. AMC members are obliged to follow the direction of the Leader in making such a judgment. The Member can file appeals of the Leader's determination to the AMC Board.



- 2. The Board may determine that no discipline shall be imposed as a result of the Report but that the member shall be notified that a Report was filed against him or her. If the Board determines that a member shall be notified of a Report, the notice shall provide a genera description of the conduct in question and may request that the member contact the President to set up a meeting to discuss the Report. If the member fails to contact the President, it may be deemed a further violation of AMC rules.
- The Board may determine that disciplinary action should be imposed in response to the Report. If the Board determines that disciplinary action should be imposed, the member shall receive a notice ("Disciplinary Notice") that includes the following information: (i) a statement that a Report has been filed against the member; (ii) a description of the alleged offense: (iii) a description of the discipline proposed by the Board; (iv) an explanation of the member's right to respond to the Report in writing; and (v) a time period within which the member must respond.

- D. If the member does not submit a written response within the time period specified in the Disciplinary Notice, the proposed discipline shall be imposed automatically upon the expiration of that time period.

 VI. Review of Written Response.
- A. If a member elects to submit a written response to a Disciplinary Notice, the Board shall review the response within a reasonable time period. The Board may, but shall have no o bligation to, schedule a meeting with the member to discuss the Report and the written response. Following consideration of the response, the Board may impose the originally proposed discipline, reduce the discipline, or impose no discipline.
- B. Once the Board has made a nation regarding the Report and the written response, the member shall receive written verification of the Board's decision ("Decision Notice"). The discipline set forth in the Decision Notice shall become effective on the date specified therein.

VII Final Determination.

- A. The determination by the Board is considered the only and final determination of the matter.
- B. No further action is available to Member upon Final Determination by the Board.



Beautiful weather and strong climbers were the main factors of our weekend in Prescott. After 3 nights of lecture, the relatively experienced class of 15 students were anxious to touch the chocolate colored basalt of Sullivan Canyon. Even though many of the students had led sport climbs prior to class, they were excited to learn about new techniques such as anchor setting, pro placement and traditional leading. After rigging their own TR anchors, we dropped down into the canyon for an afternoon of simulated aid climbing. Once the students were aiding away, most of the instructors rotated from teaching to climbing on TRs that were setup just for that purpose. Rogil snagged roughly 20 routes herself that day. I have yet to see anyone match her stamina. A fun day was had by all.

After tearing down anchors, most headed to set-up camp and then on to town. We had dinner reservations for 25 but ended up with over 30 at the Gurly Street Grill. After a few brewskis and some great food, most tiredly found their way back to camp for a good nights rest.

Sunday as usual, was a little warm once the sticky granite of Watson Dells heated up. Today was spent leading with the advantage of a top rope. The routes were mixed (bolts & gear) with a nice range from 5.5. to 5.9 for the students to practice their newly acquired knowledge. We also focus on lead belaying techniques this day. Around the corner from our class is a stiff 5.10 named Cold Shoulder. The route follows an arête on a freestanding pillar. It involves many thin, balancy moves, a gruesome mantle, and a 5.11 exit left - if you so choose. Highly recommended!! After a sweeeeet lead. David Larimer set up the climb on TR for several instructors and a few students to enjoy the route. Thanks Dave! As usual, by about 3 PM, students and instructors alike start to wear down. As a direct result we start to break down. By 4:30 Sunday we are back out to the parking lot. After the exchange of many thanks and some new friendships developing, we hop in our vehicles and join the long string of vehicles back to the Valley of the Sun.

As I reflect on the week while driving home, I hope that everyone had fun. That everyone learned and most importantly will take their knowledge, mix it with common sense and climb safely. There is only one thing worse than being injured and on the sidelines recovering. So climb smart you new leaders. You were a diverse and wonderful class. Thanks!! I hope you'll come back and help teach in February.

We had approximately 25 instructors in total throughout the week. On the weekend alone there was a combined total of 20 instructors. You guys & gals are the best. Thanks so much for all you do. A special thanks to John Keedy for filming the weeknights. I really appreciate your time and effort John. Also a very special thanks to the Sherster who "keeps the train rolling, all night long". I couldn't keep up without her. Thanks babe!!

ANCHORS SCHOOL

The AMC Anchors and Advanced Ropework School (AARS) teaches participants how to set anchors for top-roping. This course is the logical next step for AMC Basic School graduates.

First session: Learn anchor components, anchor types, knots and hitches.

Second session: Learn anchor system characteristics and construction.

Third session: Gain experience setting anchors by accomplishing "hands-on" scenarios under instructor supervision.

Fourth session: Apply newly learned skills setting real anchors. This session is a climbing outing where students set the anchors under instructor supervision and then spend the day climbing.

WHEN & WHERE (the class lasts 3 days with an optional 4th day of practice and climbing):

Nov 12, Tue. (6:00 pm - 9:30 pm): Dreamy Draw Park (Phoenix). To get to Dreamy Draw Park take the 51 (Squaw Peak Freeway) to Northern; turn east on Northern. This takes you directly into the park. Class is at the big Ramada.

Nov 14, Thu. (6:00 pm - 9:30 pm): Dreamy Draw Park

Nov 16, Sat. (8:00 am - 4:00 pm): North Scottsdale bouldering area

Nov 17. Sun. (7:00 am - 5:00 pm): Climbing area to be announced during class.

EXPERIENCE REQUIRED: AMC Basic School Graduate or equivalent which <u>must</u> include knowledge of how to belay, rappel, use prusiks, tie a figure-8-on-a-bight and figure-8-on-a-follow-through, and make a girth hitch.

<u>COST</u>: \$75 (\$88 non-members). Register by sending a check payable to AMC Anchors School to 6519 W. Aire Libre, Glendale, AZ, 85306. No credit cards accepted. EQUIPMENT REQUIRED FOR THE CLASS:

- 2 min non-locking "D" or Oval carabiners (2 minimum, bring more if you have them)
- 3 min locking carabiners (one of which should be a parabiner)
- 1 rappel/belay device (Trango Jaws, Black Diamond ATC, Trango Pyramid, Figure-8, etc.)
- 1 climbing harness
- 1 ea 4', 6', 10' 6mm prusiks (untied length)
- 2 ea 6', 10', 20' slings (1" tubular webbing, untied length, AKA runners)
- 1 or 2 personal anchor slings (commercial daisy chains or 4' sewn spectra runners or equivalent)
- l helmet

(The slings and harness are the only additional equipment needed over the Basic School requirements)

Students are required to wear a helmet during the Saturday and Sunday sessions. Helmets are available if you do not have one.

This class is designed to teach you how to set top-rope anchors. In order to become independent and set your own anchors, you should start acquiring anchor gear. These purchases will be limited by how much money you want/have to spend and how much interest you have in climbing independently. The following gear is not required for the anchors class, but if you have some, you will be able to practice setting it in a controlled, learning environment during the class. All of the gear recommended below can be used for the lead class, and none of it will be wasted if you intend to set your own anchors. All gear should be marked prior to bringing it to class to prevent confusion between it and other people's gear. If you don't know how to mark gear, check with an instructor before doing so to avoid weakening equipment due to improper marking.

OTHER GEAR you may want to bring:

- Any pro you may have (hexes, stoppers, camming devices, Tri-cams, etc.)
- Extra biners (regular D's, ovals, and lockers stay away from specialty biners at this time)
- Extra slings (perhaps four 5', two 15' slings, untied lengths)
